# From the Chairman

I was glad when they said to me let us go into the house of the Lord. – *Psalm 122:1* 

s I was thinking about what to write for my chairman's report this year, I decided to talk about something that I have never touched on before. I went through our church directory and found all the confirmed members of St. John's who live within 25 miles of our church. In the 2021 directory there are roughly 150 confirmed members residing within that 25 mile radius. This does not include children or members that I would call shut-ins or those who are physically unable to make it to church on a regular basis.

In 2021, our average attendance was 46. Does that number surprise you? It did me. Let me first say that I am not trying to offend anyone. I am sure that there are a number of reasons that members don't worship regularly, whether it be job responsibilities, illness, family obligations or they are joining us on Facebook on Sunday morning. There are also members who are worshiping at other churches. I'm sure the fear of COVID has also had an effect on our attendance as well. Whatever the reason, we want you to know that we miss seeing you and hope you will join us soon.

We are currently going through some challenging times at St. John's. Even though we are blessed to have a pastor who is serving us on a regular basis, we need to look ahead and plan for our future. The church council and call committee have been struggling with the question of whether we can financially support a full-time pastor if one would become available once Pastor Craig has fulfilled his contract in August. We have continued to have our profile and video on the NALC website, but as of a few days ago we have not been informed of any pastors wishing to contact us with interest in accepting a call to our church. We need to continue to pray that God's will be done in sending us a new pastor for our congregation. Regular church attendance is vital for the life of any congregation.

### ST. JOHN'S - VILMAR COUNCIL CAPSULE

Wednesday, Jan. 12, 2022

The St. John's Church Council met for its regular meeting on Jan. 12, 2022. Chairman Ron Salge called the meeting to order at 7 p.m. Diane Hummel read scripture from Psalms and Samuel.

#### **REPORTS**

- **Secretary:** Report was read and approved.
- **Treasurer:** Brenda Boden gave the treasurer's report, and it was approved as read.
- Chairman: None.
- Stewardship & Finance: None.
- Mission & Outreach: A thank you was received from Samaritan's Purse thanking our congregation for the donation to their organization. January mission focus will be Retrieving Freedom. Brenda gave a summary of some of the Christmas gifts that were purchased for the NB family.
- Worship & Fellowship: Diane Hummel reported that Pastor Craig would like to have a hymn sing on Jan. 30, and every fifth Sunday of the month. Council approved the request and Diane will visit with Pastor Craig more about the abbreviated order of service on those Sundays.
- **Deacons:** None.
- **Trustees:** Warren VanDyke reported that Norton has completed the tree removal and cleanup of the damaged trees around the parsonage. Warren also reported that he had consulted with Associated Crafts, who is currently repairing stained glass windows in another church in the area, to look at the current condition of the windows at St. John's. The windows were said to have an approximate value of \$109,000. An estimate on repairing and recaulking the windows was said to cost around of \$36,000. Warren said Kurt Menken is still on schedule to touch up the outside of the windows for \$50/window this year.
- Parish Ed.: Julie Eberline thanked Diane Hummel and all those individuals who were involved with the Christmas Program. There were many positive comments about how well the children did and how beautiful the service was.
- **Director of Communications:** Monica Edeker reported that she is continuing to work on reports and preparing for the annual meeting on Jan. 23.

#### **OLD BUSINESS**

- Ron Salge reported that the new speakers for the church are expected to arrive soon, however the
  amplifier may not arrive until April because of the unavailability of the chip that it needs.
- There was some discussion as to whether St. John's name should be taken off the NALC website.
   Don Salge made a motion and Julie Eberline seconded it to remove St. John's from the NALC's website call list. Motion carried

### ST. JOHN'S - VILMAR ANNUAL MEETING MINUTES

Sunday, Jan. 23, 2022

#### **OPENING**

The annual congregational meeting of the St. John's Evangelical Lutheran Church – Vilmar was held on Sunday, Jan. 23, 2022, immediately following the 10 a.m. worship service, with 31 members in attendance. The meeting began with devotion, responsive reading, and prayer. Council Chairman Ron Salge called the meeting to order. The congregational annual meeting agenda was presented and there were no additions or corrections to the presented agenda. Brenda Boden made the motion to accept the agenda and Barbara Wagner seconded the motion. Motion carried and the agenda was approved as presented.

#### **REPORTS**

- Secretary: The minutes from the annual meeting held Sunday, Jan. 17, 2021, were read by Barb Wagner. There were no corrections or additions to the minutes. Margaret DeBower made a motion to approve the minutes with Diane Salge seconding the motion. Motion carried. Minutes will stand approved as read.
- Treasurer: Treasurer, Brenda Boden reviewed the financial report for 2021. The Jan. 1, 2021 balance was \$25,028,46. Total income for 2021 was reported as \$141,435.39. Total expenses for 2021 were \$95,687.36. The operating balance was \$70,776.49 with \$14,215.87 in designated special funds. Brenda expressed her thanks for the continued financial support of St. John's and for special mission projects. There were no questions regarding the treasurer's report. Warren VanDyke made a motion to accept the treasurer's report with Don Salge seconding the motion. Motion carried.
- Nominating Committee: The ballot for 2022 elections was reviewed. Chairman, Ron Salge expressed his thanks for all those who have consented to have their name on the 2022 ballot. The floor was opened for any other nominations to the ballot. With none being made, Ken DeBower made the motion to accept the ballot as presented. Kay Brinkman seconded the motion. Motion carried. The newly elected council members are:
  - Deacons: Ron Taylor and Meredith Steere
  - Treasurer: Margaret DeBower

- Trustee: Warren VanDyke
- Stewardship and Finance: Don Salge

• Cemetery Committee: Kevin Edeker

Ken and Margaret DeBower will serve as Iowa Mission District-NALC Convocation delegates. Betty Debner will serve as the Bartels Home delegate.

• Reports from the various organizations were reviewed.

#### **OLD BUSINESS**

• Ron Salge gave an update on the new speakers that have been ordered. Updating the current sound system has been an ongoing project for some time. The speakers have been ordered and are ready to be installed pending the delivery of the amplifiers. As with many delays during the pandemic,

the amplifiers are yet not available.

• A call committee update was also given. Currently Vilmar is not actively in the call process, however our video can still be viewed on the NALC website, Vilmar's website and Facebook page. Ron reported we have not been informed of any interested pastoral candidates. Pastor Craig has been contracted through August and we are fortunate and grateful for his commitment to serving St. John's.

#### **NEW BUSINESS**

- Stewardship and Finance Chairperson, Don Salge, presented the proposed 2022 Financial budget. A correction was made for reimbursement for Pastor Craig's mileage from \$0.56 per mile (per IRS) to \$0.58 per mile. The floor was opened for questions and/or concerns regarding the proposed budget. With no further discussion, Kenny DeBower made a motion to accept the 2022 proposed budget as presented. Julie Eberline seconded the motion. Motion carried.
- Director of Communications, Monica Edeker, briefly explained the changes for the ratification of the NALC Constitutional Amendment 11. The changes made are to clarify terminology used in the amendment and each congregation needs to vote to approve or veto the proposed changes. With no questions concerning the changes Warren Van Dyke made a motion to bring to a vote the ballot to ratify the amendments to Articles 11.01, 11.02 and 11.03. Ron Taylor seconded the motion. By show of hands, St. John's voted to unanimously to approve the changes.

#### **CLOSING**

With no other business brought up Meredith Steere made a motion to adjourn the meeting with Diane Salge seconding the motion. The 2022 annual meeting closed with the Lord's Prayer.

The St. John's Church Council met briefly following the Jan. 23, 2022 annual meeting. Installation of council was tentatively set for Sunday, Feb. 13, 2022. The council dinner for incoming and outgoing council members will be held at home of Barb Wagner with a date to be determined this summer. Barb Wagner made a motion to nominate Ron Salge as council chairman and Diane Hummel as co-chairperson. Warren VanDyke seconded the motion. Motion carried and approved. There was some discussion as to the necessity of having a phone call chain when services are cancelled due to inclement weather. Currently cancellations are posted Facebook, KWWL-TV and the Hampton Radio station. The council decided that calling members was not necessary. Parishioners are welcome to call Ron Salge, Monica Edeker or any council member if needing service update.
