#### ST. JOHN'S - VILMAR COUNCIL CAPSULE

Wednesday, Jan. 13, 2021

The January Vilmar council meeting was opened with devotions given by Rhonda Edeker. Chairman, Ron Salge, called the meeting to order. Secretary's report was given by Barb Wagner. There were no corrections or additions and the report would stand approved as read. Treasurer's report was given by Brenda Boden. The operating balance is \$25,028.46 with \$46,621.91 in the general fund.

#### **REPORTS**

- **Chairman:** Ron Salge expressed his appreciation to all the council members for their time and commitment to serving on the council. Outgoing members were thanked for their time.
- Stewardship & Finance: No report.
- Mission & Outreach: Rhonda Edeker gave a report on the disbursement of December mission funds: \$920 was given to the Gideons; the North Butler Family was presented with a variety of gifts for Christmas; and the three radio stations were given \$150 each. January mission emphasis is GoServ Global.
- Worship & Fellowship: Diane Hummel reported Feb. 7 services will be conducted by Pastor David Craig; Feb 14 and Feb 21 services will by conducted by Pastor Miller. The Pastoral Committee was able to serve in home communion with several individuals.
- **Deacons:** The iPad that currently runs the sound system is locked. Monica will be contacting Wright Sound System in Waverly to try and resolve the issues.
- Trustees: No report.
- Parish Ed.: No report.
- **Director of Communications:** Monica noted that the record books that are currently used for the recording of baptisms, confirmations, deaths, etc. are showing age. Rhonda Edeker made a motion to purchase a new record book using memorial money. Motion carried. Council was given a listing of Herald mailings. St. John's is now offering a digital version of the Herald. Members were asked to request their preference in a survey mailed in 2020. Council members will be contacting members who have not responded to find out their preference in receiving the Herald.

#### OLD BUSINESS

• The new live streaming system will be installed soon.

#### **NEW BUSINESS**

- Council was given a sample ballot for elections. Brenda Boden made a motion to approve the 2021 ballot. Warren VanDyke seconded the motion. Motion carried.
- The annual meeting will be held Sunday, Jan. 17, 2021. The agenda for this meeting was presented. After reviewing the agenda, two additions were made. Don Salge made a motion to approve the agenda for the annual meeting. Jason Edeker seconded the motion. Motion carried.
- The Call Committee has been formed. This committee will consist of Monica Edeker, Diane Hummel, Doug Schueler, Marc Seehusen, Julie Eberline, and Barb Wagner. Ron Salge, as Church Council President will be an ex-officio member of the Call Committee.

- Don Salge presented the proposed budget of \$68,286.00 for 2021. After reviewing and discussion Jason Edeker made a motion to approve the proposed 2021 budget. Diane Hummel seconded the motion. Motion carried.
- On Sunday, Jan. 31, 2021, a congregational workshop will be held and conducted by Pastor Staley. The purpose of this workshop is to put together a congregational profile that will be used in calling a pastor for St. John's. Pastor Staley expressed that this meeting is an important step in the call process and is one way that all members of St. John's can be involved. The meeting will begin at 1 p.m., and is expected to take 4-5 hours.
- Helen Debner is stepping down as the Memorial Fund chairperson. The council appreciates and thanks Helen for her years serving in this position. Diane Salge was appointed the new contact person for recording memorials and the council appreciates her willingness to serve. Rhonda Edeker made a motion to accept Diane Salge as the Memorial Fund contact person. Jason Edeker seconded the motion. Motion carried.

#### ST. JOHN'S - VILMAR ANNUAL MEETING MINUTES

Sunday, Jan. 17, 2021

#### **OPENING**

The annual congregational meeting of the St. John's Evangelical Lutheran Church – Vilmar was held on Sunday, Jan. 17, 2021 immediately following the worship service at 11 a.m., with 27 in attendance. The meeting began with devotion, responsive reading and prayer. Council Chairman Ron Salge called the meeting to order. The congregational annual meeting agenda was presented. There were no additions or corrections to the presented agenda. Jim Wubbena made the motion to accept the agenda as presented. Isabella Seehusen seconded the motion. Motion carried.

#### **REPORTS**

- Secretary: The minutes from the 2020 Annual Meeting held Jan. 26, 2020 were read by Barb Wagner. There were no corrections or additions to the minutes. Diane Salge made a motion to approve the minutes and Brenda Boden seconded. Motion carried. Minutes will stand approved as read.
- Treasurer: Brenda Boden, reviewed the financial report for 2020. The operating balance for 2020 was \$25,028,46. The general fund as of Dec. 31, 2020 was \$46,621.91. The floor was opened for any questions concerning the budget. Rhonda Edeker made a motion to approve the 2020 Treasurer's Report. Margaret DeBower seconded the motion. Motion carried.
- Nominating Committee: The ballot for 2021 elections was reviewed. The floor was opened for any other nominations to the ballot. With none being made, Ken DeBower made the motion for nominations to cease with Kenny Debner seconded the motion. Motion carried. A motion to accept the unanimous ballot for elections was made by Jeff Seehusen and seconded by Warren VanDyke. Motion carried. Chairman Ron Salge thanked the outgoing council members and expressed appreciation to the nominating committee. The newly elected council members are:
  - Deacons: Tyler Seehusen and Ron Salge
  - Parish Ed.: Julie Eberline
  - Cemetery Committee: Meredith Steere

• Trustee: Evan Steere

Mission and Outreach: Barb Meyer

Bob and Karen Janssen will serve as delegate and alternate for the NALC Convocation. Ken and Margaret DeBower will serve as Iowa Mission District-NALC Convocation delegates. Betty Debner will serve as the Bartels Home delegate.

- Reports from the various organizations were reviewed. Diane Salge will be the new Memorial Fund chairperson. Helen Debner was thanked for serving as chairperson for many years.
- Diane Hummel, Worship and Fellowship Committee chairperson, expressed her thanks for the pastors who have been assisting with our services at Vilmar.
- Director of Communications, Monica Edeker, briefly explained the Pastor Discretionary Fund, which is now an account at the Iowa State Bank in Clarksville. She also reviewed the Pastoral Acts and Statistical Parochial Report.
- Rhonda Edeker gave an overview of the 2020 Mission and Outreach Report. St. John's continues to embrace their call to be a "mission-driven" church contributing to local, national and international organizations. Total mission funds spent in 2020 was \$11,102.16.

#### **OLD BUSINESS**

#### **NEW BUSINESS**

- Don Salge, Stewardship and Finance Chairman, reviewed the 2021 proposed budget of \$68,286.00. There were no questions or concerns regarding the budget. Rhonda Edeker made a motion to approve the budget as presented. The motion was seconded by Dean Brinkman. The motion carried and the budget will stand as outlined.
- Ron Salge reviewed a ballot on the 2021 Ratification of Constitutional Amendments of the North American Lutheran Church (NALC). The two resolutions needing to be voted on are:
  - Delete in Article 7.02 the specific number of baptized members for the apportionment of additional lay delegates to the convocation, and to clarify the Executive Council's responsibility for apportioning additional lay delegates to meet the requirement that "at least an equal number of layperson" and ordained NALC ministers serve as delegates at each convocation, and
  - Change the requirement for an annual convocation to a biennial convocation; to amend articles to make the transition from annual to biennial; amend article to require each convocation to adopt a budget for the next two calendar year; and
  - Amend article to require the Executive Council to report quarterly all action to congregations and clergy, as well as to each convocation.

Jim Wubbena made a motion to accept the constitutional amendments to the NALC. Ron Taylor seconded the motion. There were no questions from the floor. Motion carried.

- Ron Salge shared that the Call Committee is now formed and will be moving forward in the call process once the Congregational Workshop is completed on Sunday, Jan. 31, 2021. Those serving on the call committee are: Monica Edeker, Diane Hummel, Doug Schueler, Marc Seehusen, Julie Eberline, and Barb Wagner. Ron Salge, as Church Council President, will be an ex-officio member.
- A concern was brought up about church information in the local newspapers not being updated weekly. Monica explained that she has sent monthly updates to each paper, but the information has yet to follow through with the corrections. This issue will be checked into again.

#### **CLOSING**

With no further business Bill Debner made a motion to adjourn the meeting. Betty Rewerts seconded that motion. The meeting closed with the Lord's Prayer.

The St. John's Church Council met briefly following the Sunday, Jan. 17, 2021 Annual Meeting. Assignments were handed out for the prayer chain / weather cancellation notifications. Nominations were opened for the council chairperson position. Brenda Boden made a motion to nominate Ron Salge as St. John's Council President. Barb Wagner seconded the motion. Motion carried. A special council meeting will be held following the worship service on Sunday, Jan. 24 to discuss the Herald. The next regular council meeting will be held Wednesday, Feb. 10, 2021 at 7 p.m.
